1. Invitation

You are being invited to take part in this survey which is being carried out as part of a study supporting the future-proofing of the 2017 EU One Health Action Plan against AMR. 2. What is the project's purpose?

4. Who is organizing and funding this survey?

This survey is being performed by ICF S.A, who is the Data Controller with DG SANTE, who have commissioned the research. As this activity involves the processing of personal data, it is subject to data protection rules as established by:

9. What technology is being used to conduct the survey?

For the purpose of this survey, the Data Controller will use Qualtrics. This specialized online survey application is designed to be compliant with all applicable EU data protection regulations and laws. Survey data are hosted on secure servers in Germany with backups in Ireland.

10. Who has access to your information and to whom is it disclosed?

Access to all personal data and information collected in the context of this survey is only granted through UserID/Password to the survey designers from ICF, without prejudice to a possible transmission to the bodies in charge of a monitoring or inspection task in accordance with Data Protection and GDPR Legislation. The collected personal data and all information related to the above-mentioned survey are stored on secured and protected servers of Qualtrics (the Data Processor) located in Germany with backups in Ireland.
