

End User Licensing Agreement

Please carefully review this Software License Agreement before using any software provided by Edgeless Systems. If you are agreeing on behalf of an organization, you confirm that you have the authority to bind that organization to these terms. This Software License Agreement does not extend to services such as software maintenance, updates, or support from Edgeless Systems. Separate service or subscription agreements may detail those services and any associated fees.

This end user license agreement ("EULA") applies to the licensed use of the Edgeless Systems software application that references this Agreement, including any related updates, source code, design, structure, and organization ("Software"), irrespective of the method of delivery.

1. **License Grant.** Edgeless Systems GmbH ("Edgeless Systems") hereby grants you a non-exclusive, global license to utilize the Software, which may encompass multiple software components.
